4.2. Current status of NTEP Conformity Assessment Progress

Darrell Flocken provided an update on the VCAP activities that have currently been completed.

Of particular interest to the SMA, the NTEP Committee will discuss the option of adding LRE's 2000 lbs and less using NTEP load cells to the list of devices required to have a VCAP audit. The NTEP Committee is looking for additional comments at July Annual Meeting.

Three items were discussed under New Business". The first item was regarding two new proposals to the S&T committee that address the  $v_{min}$  Relationship Formula found HB 44. The second item was a request from NIST asking for SMA to participate on an OIML work group to address a document: "Principles of Metrological Control for Measuring Instruments Throughout the Instrument's Lifecycle". The third item was a request from CECIP to include the "weighing industry" in the "Transatlantic Trade and investment Partnership" and ask the SMA to review their position paper and possibly draft a joint position paper.
